WASHINGTON PAYMENT PLAN

If you cannot repay your current loan as planned, Washington law gives you the right to opt into a payment plan after four successive loans. A successive loan is one that you take out within three days after you have paid off your previous loan. Key features of the Washington Payment Plan include:

- You may enter into the payment plan before your current loan is deposited or paid.
- A fee equal to the loan fee on the outstanding loan is due at the time you set up the payment plan.
- You may set up payment arrangements to repay the loan in at least three (3) payments over at least 60 days.
- Payment due dates will be timed with your paydays.
- We will not begin collection activities while your payments are made as agreed.
- During the payment plan period, you will not be eligible to take out another payday loan with Moneytree.

CFSA EXTENDED PAYMENT PLAN

As a member of the Community Financial Services Association (CFSA), Moneytree offers you the right to opt into the CFSA Extended Payment Plan if you cannot repay your current loan as planned. Key features of the CFSA Extended Payment Plan include:

- You may enter into the extended payment plan before your current loan is deposited or paid.
- There is no fee to enter into this payment plan.
- You may set up payment arrangements to repay the loan in at least four (4) equal payments.
- Payment due dates will be timed with your paydays.
- We will not begin collection activities while your payments are made as agreed.
- During the payment plan period, you will not be eligible to take out another payday loan with Moneytree.
- You will be eligible to enter into a subsequent CFSA Extended Payment Plan one year from the date the prior CFSA Extended Payment Plan was originated.

OTHER INFORMATION

For both types of payment plans, you will be in default on your payment plan if you fail to make any payment as agreed. If you default on your payment arrangements, the total unpaid balance will be due immediately and you will be charged a default fee of \$25.
